In general, services are provided on a limited basis, and alternatives may exist that may not be provided within the scope of this clinic.

After the application is approved, prepaid appointments will be scheduled based on availability.

PLEASE CALL TO SCHEDULE AN INTAKE APPOINTMENT, WHERE YOU WILL NEED TO BRING ALL THE BELOW DOCUMENTATION AND THE REST OF THE APPLICATION:

1. **Proof of Income** – Bring last year's **tax return, SSI letter, or three consecutive paystubs** for **ALL** members of the household. We need proof of any other household income.
2. **Photo Identification**
3. **Proof of LEGAL Livingston County residency** – Bring current *entire* utility bill, DTE or Consumers Energy. If using water bills or phone bills, we will need 6 consecutive months. Other options include a voter registration card, auto registration, or dated rental agreement. **SIX MONTHS** of legal residency is required.
4. Patients pay \$25.00 in cash, credit/debit card, or money order *in advance* for an appointment. No personal checks.
5. **WE HAVE A VERY STRICT NO SHOW/CANCELLATION policy.** No-shows or last-minute cancellations are not acceptable: First no-show or last-minute cancellation, a warning is given; Second no-show or last-minute cancellation: the patient will be dismissed from the VINA Dental program. The \$25.00 fee will be lost in either case, and you will be put at the bottom of the list for another appointment.

Another payment must be made before another appointment is scheduled.

48 hour notice is required to change an appointment.

We are pleased to provide the following information about the VINA Community Dental Center. Our mission is to provide quality, affordable dental care to eligible Livingston County residents with limited finances and no access to dental care while upholding the professional standards of dentistry in a concerned and compassionate way.

ELIGIBILITY: Patients must meet ALL 3 requirements:

1. Individuals must live in Livingston County. 6 months legal residency is required.
2. Households must have NO dental insurance.
3. Households must have an income at or below 250% of federal poverty level. This also includes public assistance, social security, and unemployment.

IMPORTANT INFORMATION:

Bring proof of family income and legal residence every 6 months to be re-qualified.

Your appointment will require a \$25.00 fee to hold the appointment or be placed on the call list. We accept the following forms of payment: Cash

Credit Cards (VISA, MC, Discover)

You will lose your appointment fee if you: do not show up for your appointment

VINA reserves the right to discharge a patient from care at its sole discretion. Grounds for discharge may include, but are not limited to, the following:

1. Failure to comply with or follow the treatment recommendations of VINA's providers
2. Conduct that is aggressive, hostile, threatening, disrespectful, or otherwise disruptive to staff, volunteers, or other patients
3. Repeated failure to attend scheduled appointments at VINA or any referral office
4. Presenting with medical or dental needs that exceed the scope of services available through VINA and/or its volunteer specialty network
5. Attempting to direct, dictate, or otherwise inappropriately influence the course of clinical treatment
6. Significant or extended gaps in treatment without reasonable justification
7. Failure to continue meeting VINA's patient eligibility criteria, including but not limited to requirements related to insurance coverage, residency, and income

This list is not exhaustive. VINA retains the authority to discharge any patient when, in its judgment, continued care is no longer appropriate, feasible, or in the best interest of the patient, staff, or organization.
